1. OFFICIAL NEWS

1.1 Message of the President



Dear EACES members and friends,

In the last three months we witnessed interesting events and activities of EACES that you will find summarised below. Our treasurer, Prof. Jens Hölscher took part in an impressive and well attended congress in Seoul, organised by our Korean, American, and Japanese colleagues, from the Association for Comparative Economics Studies and the respective national associations. Thanks to their efforts and those of Pasquale Tridico and Marcello Signorelli it is likely that we will organise a joint world congress of the associations, a year after our own biennial congress in Budapest next year.

These are all excellent news.

A piece of bad news we just received however that is our colleague and one of the most prominent comparative economists Prof. Sergei Guriev had to leave Moscow last month. We had a pleasure to listen to the fascinating keynote presentation by Prof. Guriev at our congress at Paisley. He talked about history, considering the outcome of Soviet collectivisation and forced industrialisation, and comparing it with counterfactual scenarios of development. It was an impressive piece of scholarship based on thorough programme of data collection and statistical processing. The conclusion was that Russia could be better off with a market driven adjustment, not just in terms of human cost, but also in terms of direct economic outcomes. That way, Prof. Guriev tackled an important long persisting, historical myth.

It is a pity that it is unlikely he will be able to continue at the New Economic School (*Российская экономическая школа*) that he made such a strong academic institution, visible not just in Russia, but far beyond. We have no doubt however that more of novel, thought provoking scholarship is to come from Prof. Guriev and we will all be waiting for it.

Meanwhile, please have a warm, sunny and quiet summer.

1.2 Workshop on Firm-level Studies on Productivity, Trade, and Innovation



EACES Workshop on FIRM-LEVEL STUDIES ON PRODUCTIVITY, TRADE AND INNOVATION

**University of Tartu, Estonia
24 – 25 May 2013**

During May 24-25 University of Tartu (located in the old university town of Tartu) in Estonia hosted the EACES workshop on “Firm-level studies on productivity, trade, and innovation”. The list of participants included 25 researchers from Estonia, UK, Germany, Italy, Netherlands, Latvia, including the partner institutions of EACES (Halle Institute for Economic Research, University of Trento). As indicated by the title, the event focused on empirical studies using firm level data to study issues related to firm performance, like the determinants of productivity (innovation, international trade, intangible assets), firms’ engagement in international trade (entry patterns, product level export dynamics, dynamics of export prices), innovation (linkages with productivity, cooperation between universities and enterprises, patenting), foreign direct investments (knowledge transfer and its effects on productivity). The local organizers from the University of Tartu were Priit Vahter, Urmas Varblane and Jaan Masso. The keynote speaker was Pierre Mohnen from the University of Maastricht. This seminar is envisioned to be the first in a series of regular seminars at University of Tartu on empirical firm-level studies.

Proposals for pressing ahead with deeper political integration for EMU countries - a step towards a 'two-speed Europe' that would leave the Poles outside, have been received reservedly in Warsaw.

This conference aims to contribute to discussions on the future shape of economic and monetary union (EMU) and the next steps ahead. Contributions on all aspects are welcome in **the form of 300 word abstracts**.

We aim to publish a selection of conferences papers with the Palgrave/Macmillan's book series 'Studies in Economic Transition'.

EACES Workshop “Competitiveness of Firms, Industries and Countries - Cause and Solution of European Crises”

20th -21st September 2013, Belgrade, Serbia

The International Scientific Workshop “*Competitiveness of Firms, Industries and Countries - Cause and Solution of European Crises*” is jointly organized by the Faculty of Economics, University of Belgrade and the European Association for Comparative Economic Studies (EACES). The Workshop will take place at the Faculty of Economics in Belgrade from 20th to 21st September 2013.

The global financial crisis and the crisis of the European Union have both revealed that current account deficits become unsustainable if they are coupled with a weak competitiveness of the country. International reports (Global Competitiveness Report 2012/2013 of the World Economic Forum, but also other sources) illustrate competitiveness indicators of the Balkan region, and Southern and East-European members of the E(M)U are below average. Re-balancing the economy and balanced growth require strategies for improving competitiveness. The workshop has two aims: (i) discovery of the most important sources for weak competitiveness, and (ii) discussing the political strategies to overcome weak competitiveness.

With respect to the first aim, papers with empirical findings applying state-of-the-art methodology are highly welcome. Studies should have a focus on three levels: firms and industries, aggregate-macro indicators and the integration into international production processes (keyword: global value chains).

With respect to the second aim, papers with a focus on institutional reforms, policy reforms (education & technology), and fiscal-monetary arrangements will be particularly welcome.

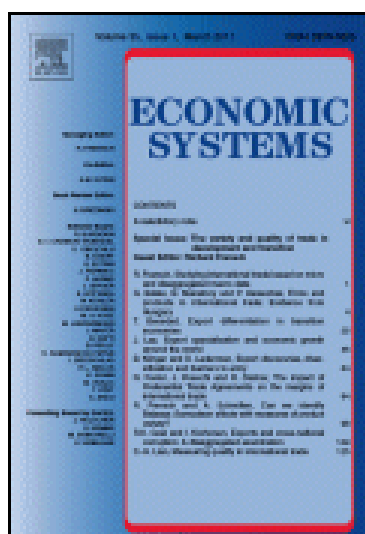

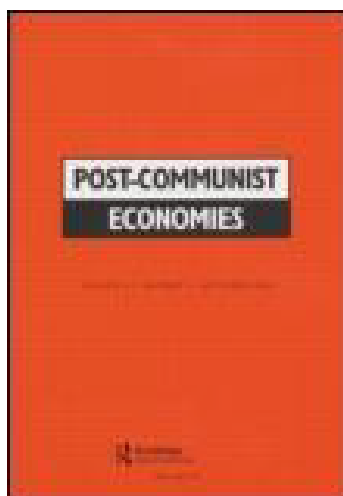

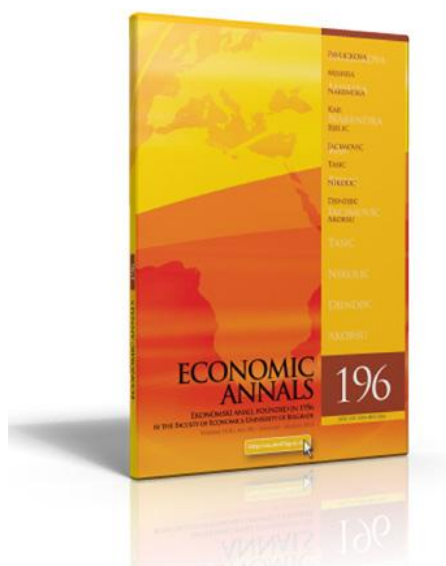

Editorial:

The presidential message in this 66th issue of the EACES newsletter summarises the important events during the past three months. EACES treasurer - Prof. Jens Hölscher -- participated in the impressive congress in Seoul organised by Korean, American, and Japanese colleagues in the Association for Comparative Economics Studies and the respective national associations. Likewise, efforts are underway, especially by Pasquale Tridico and Marcello Signorelli, to organise our own biennial congress in Budapest in 2014. As Prof. Sergei Guriev is now leaving the New Economic School (Российская экономическая школа), his new destination and thought provoking endeavours will be reported in forthcoming issues of the newsletter.



University of Tartu in Estonia hosted the EACES workshop on “Firm-level studies on productivity, trade, and innovation” during May 24-25 this year. Altogether 25 researchers from Estonia, UK, Germany, Italy, Netherlands, Latvia, and EACES partner institutions (Halle Institute for Economic Research, University of Trento) participated in the workshops. The event mainly focussed on empirical studies on firm performance, such as the determinants of productivity (innovation, international trade, intangible assets), firms’ engagement in international trade (entry patterns, product level export dynamics, dynamics of export prices), innovation (linkages with productivity, cooperation between universities and enterprises, patenting), and foreign direct investments (knowledge transfer and its effects on productivity). Thanks to the local organisers from the University of Tartu -- Priit Vahter, Urmas Varblane and Jaan Masso – to the efforts. Pierre Mohnen from the University of Maastricht delivered the keynote speech. This workshop was the first in this nature at University of Tartu on empirical firm-level studies. Section 1 of this newsletter presents the report of the successful completion of this workshop. Section 2 reminds the call for proposals for Poland and Eurozone Conference to be organised in Bournemouth University jointly with EACES in 19-20 September 2013. As one of the Europe’s out-performers, Polish history and geography encouraged it to be in favour of deeper European integration. But current setbacks affecting the EURO has impacted Poland's European stance with caution. The conference would focus on these prospects and challenges.

A summary of the forthcoming conferences/workshops/seminars has made the subject matter of Section 3. Three major events are underway in this regard: ERSA-EACES Special Session on Young people, Education and Labour Market in University of Palermo, Italy during 27-28 August 2013; The 54th Annual Conference of the Italian Economic Association at the University of Bologna, in 24-26 October 2013; and EACES Workshop on Competitiveness of Firms, Industries and Countries to be held at the Faculty of Economics, University of Belgrade during 20-21 September 2013. We expect the reports from these events to accommodate in the forthcoming issues of the newsletter. Section 4 provides information on the recent publications of the European Journal of Comparative Economics, Economic Systems, Post-Communist Economies, European Journal of Development Research, Economic Annals, Comparative Economic Studies, and Journal of Comparative Economics.
